North Immanuel Annual Meeting January 28, 2024

Council President Brad Knorr called the meeting to order at 9:35 a.m.

Pastor Isaiah led with prayer.

Last year's annual meet minutes were read, motion made by Paul Nord to accept and place on file, 2nd by Brian Johnson. Motion carried.

Pastor's report read by Isaiah and placed on file.

Brad addressed attendees and thanked everyone for coming. He stated that the council worked well together throughout the year.

Treasurer's report: Julie Ann Holt summed up the budget and proposed budget, noting a large donation that was made and that there is still more to come. Overall, we kept in-line with the budget.

Brad and attendees thanked Julie Ann. Jane Knorr will handle deposits and bills during Julie Ann's absence.

Committee reports:

Evangelism: NI will have 2 outdoor services in June, 1 in July and 1 in August of 2024.

Stewardship: Dave Dunham reminded attendees that the Seed and Feed delivered through email has brought down costs for postage, paper, ink and time. If you want to receive it via email or know anybody who would, email Kara at nilchurch@yahoo.com.

Christian Education: Thanked everyone who helped with VBS, had a great turnout.

Property and Management: The stained-glass window project is underway. Church will be held downstairs in the meantime. Windows are expected to be completed by the end of February.

Ballots were handed out for the following nominees:

Council: Grant Meyer, Nolan Dunham, and Tom Axness

Jane Knorr made a motion to cease nominations, Sandie Strandlien 2nd. Motion carried.

Brian Johnson made a motion to approve ballot by a unanimous vote, Becky Lage 2nd, motion carried.

Heidi Fouquette requested to be added to the cemetery board nominee ballot. Thereafter, the cemetery board nominees were: Heidi Fouquette, Steve Strandlien, and Wayne Hovland. Leon Dunham made a motion to cease nominations, 2nd by Dave Fouquette. Motion carried. Ballots were distributed. The two open terms were filled by Steve Strandlien and Wayne Hovland.

The Christian Education ballot lists Kaitlin Bai as a nominee. Dawn S. made a motion to cease nominations, 2^{nd} by Jane, motion carried. Duane Ishaug made a motion to approve ballot by a unanimous vote, Dave Fouquette 2^{nd} , motion carried.

An amendment to the budget was discussed to increase Pastor Isaiah's monthly benefit by \$166.19 to help with half of his current health insurance monthly premium. Sandie S. made a motion to approve the amendment, Jane 2nd, motion carried.

Dar Hovland made a motion to accept the proposed budget for 2024, Sandie 2nd, motion carried.

Unfinished business: Pastoral review: Dave Fouquette, Janice Ness, Bryant Briard, the council president, vice president and secretary will be on the pastoral review committee. The new council will set a date for review. Dave requested emails of fellow committee members so he can send examples of review questions to compile a comprehensive review.

New business: A discussion regarding on-line offering resulted in the request of Bryant and Allison Briard and Shyla Strandlien to provide the council with information and various options.

A suggestion was made to increase our church benevolence since NI has received a large donation. Brad requests that the new council address this, and that anyone who knows of a need or has ideas for beneficiaries, bring to the council's attention.

The idea of upgrading NI's streaming of worship services was discussed. Brad, Wayne and Steve went to see first-hand a church with upgraded equipment. The upgrade would require assistance from members who are comfortable with technology to operate the equipment during each service. Bryant made a motion to form a committee, Becky 2nd, motion carried. The committee will be Allison, Shyla, and Krystle to spearhead this operation.

Dave Fouquette made a motion to amend the budget to allow \$5000 for such upgrades, Krystle Meyer 2nd, motion passed.

Nominations for a new nominating committee for next year were as follows: Dave Dunham and Conni Axness. Approved.

Jane made a motion to destroy ballots, Krystle 2nd, motion carried.

Dave Fouquette made a motion to adjourn, Dar Hovland 2nd, meeting adjourned at 10:55
